Conditions of Entry (please keep a copy for your records)

- 1. We want everyone to enjoy the event and these conditions have been drawn up for your guidance, the exhibitor, and with visitors to Ashby Steam in mind. By entering your exhibit you are agreeing to comply with these rules and conditions.
- 2. This is a two day event, exhibits are preferred to be booked for both days. If attending one day only, please specify which day on the form. You will be required to be on site by 9am and stay until the event closes at 5pm.
- 3. The speed limit on site is 5mph and there must be no vehicle movement on site between 9am and 5pm unless authorised by Organisers as part of the event (e.g. moving to and from the main arena).
- 4. No passengers or dogs/pets are allowed to be carried on moving tractors or trailers or transport boxes, regardless of seat or cab configuration, at any time.
- 5. All instructions issued by the Organisers (Ashby Steam Ltd), the Site Manager, the Safety Officers, the Section Stewards and Marshals must be followed. By entering this form, you agree to abide by these.
- 6. All exhibits must be covered by insurance as required by the relevant Road Traffic Acts and must also have personal liability cover of not less than £2,000,000.
- 7. Ashby Steam Ltd is not liable for any accident or injury caused by exhibitors or persons under the exhibitor's direction or by the exhibitor's vehicles or equipment including camping.
- 8. Only those insured to do so are allowed to start, drive or otherwise operate the exhibit
- 9. All exhibits must be suitable for the use to which it will be put during the event and must be in good, complete and safe working condition.
- 10. All exhibits are displayed at the owner's risk. Ashby Steam Ltd is not responsible for any loss or damage which may occur.
- 11. Entry is on a first come, first served basis and the Organisers reserve the right to decline entries at their discretion. The closing date for entry is 1st June 2024.
- 12. One tent/caravan is permitted per exhibit situated in the allocated camping area.
- 13. For 2024, wristbands will be allocated as follows and will be available to collect from the booking area on site:

- 14. All steam exhibits (including miniature) are required to have a full and current boiler certificate. These will be checked by the organisers.
- 15. You must enclose an A5 sized stamped addressed envelope with your completed entry form. Packs will be posted out approx. 1-2 weeks before the event.
